LPS Monthly Report Lethbridge Police Commission

NOVEMBER 2025

The Lethbridge Police Service is committed to providing a safe community for all. Monthly highlights from each division that contribute to our organizational priorities – community safety, community engagement and healthy organization – and in line with our annual policing plan goals:

- Reduce crime
- Increase capacity by reducing police response to calls that can be alternatively reported and do not require the attendance of an officer
- Increase citizen perceptions of safety
- Increase community crime prevention initiatives
- Increase satisfaction with LPS
- Increase visibility within the community
- Promote information-sharing and collaboration with partner agencies
- Enhance employee health and wellness initiatives
- Increase diversity within the organization to better represent the community we serve
- Enhance technology to address security issues and keep pace with organizational needs

FIELD OPERATIONS DIVISION:

- The Downtown Policing Unit (DPU) has been deploying a targeted enforcement project in conjunction with the Property Crimes Unit, Crime Suppression Team and the Lethbridge SCAN team leading to multiple arrests and charges. The October project led to the execution of 74 arrest warrants and the recovery of one stolen vehicle.
- DPU members performing proactive patrols resulted in a male being charged in connection with the theft of five firearms and \$60,000 worth of stolen property.
- Center Village Mall and Park Place Mall continue to experience increased levels of theft and trespassing.
- Encampments around the shelter continue to be a significant challenge leading to extensive time by DPU in the area.
- The Public Order Unit was deployed to a rally in Galt Gardens due to the potential for conflict with counter-protesters. The event was concluded with no major issues.
- The mail-out of Automated Enforcement Tickets has resumed via Canada Post.
- Two members of the Traffic Response Unit (TRU) are taking a Level 3 collision reconstruction course.
- TRU provided traffic control during the Take Back the Night event to ensure the safety of all participants.

- Three Community Peace Officers will complete their field training and be signed off for solo deployment by the end of the month.
- PACT members met with City of Lethbridge employees to discuss a possible alternative response model for mental health calls and took part in the Mental Health and Addictions Advisory Committee.
- The Community Engagement Unit managed the Remembrance Day ceremony, participated in a training session regarding the Low German Mennonite community, met with Lethbridge Family Services about possible programming for newcomers to Canada and helped harvest the Blackfoot Medicine Gardens.
- The FASD Officer assisted in three investigations.

CRIMINAL INVESTIGATION DIVISION:

- The Property Crimes Unit, High Risk Offenders Unit and Integrated Offender Management investigated more than 30 files. Five remain under investigation.
- The first-ever participant was signed in to the Integrated Offender Management Program.
- Two members of the Property Crimes Unit attended an in-house training program related to covert surveillance techniques.
- The Crime Suppression Team concluded five investigations.
- The Economic Crimes Unit has been averaging one awareness presentation per week to various community organizations and recently met with the Civil Forfeiture Office to learn more about roles and responsibilities as well as opportunities for further collaboration.
- The Violent Crimes Unit (VCU) assumed multiple investigations, including files involving a sexual assault, uttering threats, two assaults and extortion.
- The LPS polygrapher conducted a number of recruitment polygraph examinations and assisted RCMP with an historical file.
- One member of VCU completed a Statement Suitability training course.
- Lethbridge ALERT completed Operation Lineage, resulting in search warrants executed at two local residences. Investigators seized nearly \$15,000, 40 grams of cocaine and 145 MDMA tablets. One female was charged.
- November is Family Violence Prevention month and the Domestic Crimes Unit and Communications Unit have shared awareness messaging on social media.

SUPPORT SERVICES DIVISION:

- In October, the Recruiting Unit attended two police advisory committee meetings, the Alberta Association of Chiefs of Police fall meeting and hosted the Canadian Criminal Justice Academy students for an information session.
- The follow-up audit for the LPS vehicle impound lot has been completed. All items were accounted for with only minor clerical or administrative errors detected. These have been remedied and recommendations made to assist in the emphasis of protocol adherence among staff.
- Victim/Witness Services (V/WSU) received 79 applications during their recent recruitment an all-time high! It is anticipated 15-20 new Crisis Support Workers will be selected from this group and join the team following training in January.
- Over the summer LPS staff tended four sacred plants in rooftop gardens mint, sage, sweetgrass and tobacco. Under the guidance of local Blackfoot Elders the plants were harvested and the yield will be used in cultural ceremonies hosted by LPS and the V/WSU smudge kit program where volunteers create smudge kits that are provided to community members in times of crisis.
- V/WSU members attended the Dogs with Wings Gala. Facility Dog Cruiser was featured
 during the welcome and he and his handler, Cat Pooley, provided a demo for the event
 showcasing some of the games (Kerplunk) he plays with victims to help with regulation.
- For the period of October 1 October 31, the Governance and Compliance Unit reviewed/updated/created and published two directives:

Team A, responding LPS members

Sgt. Hansen wanted to identify the excellent work of PACT member Cst. K Easter and RN Tower during a recent call involving a patient with dementia. Cst. K Easter did an outstanding job dealing with the patient utilizing her excellent communication skills to navigate the patient's outbursts and guide them in agreeing to attend CRH - a feat which took multiple police officers during a previous Level 1 critical incident response with this same patient. RN Tower demonstrated a high level of professionalism in dealing with AHS during this challenging call.

"During this call for service an elderly female was out of her medications, had mobility issues and was living in a situation not conducive to her needs. Cst. Brett did a community referral to a great program and then asked PACT to review the file and offer any other additional supports or recommendations. Cst. Brett contacted the female's pharmacy, got them to deliver her medications and then delivered her an emergency food hamper the day after the initial interaction. Cst. Brett identified that the female really wished to speak and hug her son again before she died and attempts were made to contact him. Cst. Brett even sent a letter to the son's last known address, asking him to contact Cst. Brett if he wished to have communication with his mother.

Cst. Brett is the type of officer I am proud to work alongside. Cst. Brett saw a need, found a solution and showed empathy and compassion."

Sgt. Demone and Janay Spanos

Cst. S Stock sent an email to highlight how Sgt. Demone and Janay Spanos excelled during a Critical Incident Scribe training course they attended in Medicine Hat. REPORTED CRIME VIOLATIONS IN LETHBRIDGE: JANUARY TO AUGUST 2019-2025

Executive Summary

When comparing January-August 2025 to January-August 2024:

- Total crime violations increased by 13.8%, and total Crime Severity Index (CSI) score increased by 8.1%
- Person crime violations increased by 7.4%, and person crime CSI score increased by 3.4%
- Property crime violations increased by 12.2%, and property crime CSI score increased by 5.3%

When comparing August 2025 to August 2024:


- Total crime violations increased by 27.6% and total crime Severity Index (CSI) score increased by 25.5%
- Person crime violations increased by 22.1% and person crime CSI score increased by 27%
- Property crime violations increased by 24.8% and property crime CSI score increased by 22.3%

Crime by City Region: January-August 2025 compared to 2024

- Downtown Lethbridge; crime violations increased by 14.9% and CSI score increased by 9.2%
- North Lethbridge; crime violations increased by 10.7% and CSI score increased by 2.6%
- South Lethbridge; crime violations increased by 20.8% and CSI score increased by 11.1%
- West Lethbridge; crime violations increased by 0.6% and CSI score increased by 3.1%


Total Crime: Violations vs CSI (Year Over Year Change)






August Crime: Violations vs CSI (Year Over Year Change)






Crime Hotspots: Top Neighborhoods January to August 2025




Lethbridge Regions: Crime Violations Previous Year VS Current Year




Lethbridge Regions: CSI Score Previous Year VS Current Year




Downtown Lethbridge Top 5 Violations - August 2025




North Lethbridge Top 5 Violations - August 2025




South Lethbridge Top 5 Violations - August 2025




West Lethbridge Top 5 Violations - August 2025




Total Person Crime: Violations vs CSI (Year Over Year Change)






August Person Crime: Violations vs CSI (Year Over Year Change)







Total Property Crime: Violations vs CSI (Year Over Year Change)






August Property Crime: Violations vs CSI (Year Over Year Change






Total Assault: Violations vs CSI (Year Over Year Change)






August Assault: Violations vs CSI (Year Over Year Change)



Total Robbery: Violations vs CSI (Year Over Year Change)







August Robbery: Violations vs CSI (Year Over Year Change)




Total Sexual Assault: Violations vs CSI (Year Over Year Change)




August Sexual Assault: Violations vs CSI (Year Over Year Change)



Total Break & Enter: Violations vs CSI (Year Over Year Change)







August Break & Enter: Violations vs CSI (Year Over Year Change)



Total Shoplifting: Violations vs CSI (Year Over Year Change)






August Shoplifting: Violations vs CSI (Year Over Year Change)






Total Mischief: Violations vs CSI (Year Over Year Change)





August Mischief: Violations vs CSI (Year Over Year Change)




Total Theft from Motor Vehicle: Violations vs CSI (Year Over Year Change)




August Theft from Motor Vehicle: Violations vs CSI (Year Over Year Change)

Issue: Opening on Finance Committee

Key Messages:

 Councillor Paladino did not seek re-election and therefore ceased to be a member of the Lethbridge Police Commission as of October 20th, 2025.

- Councillor Ryan Wolfe was elected and appointed by Council to the Lethbridge Police Commission on November 3rd, 2025.
- Commissioner Wolfe provided staff with a clear Police Information Check and received orientation on November 24th.
- Committee appointments usually occur on the first meeting in January, and there is a succession planning discussion set for January 7th wherein 2026 appointments to committees could be discussed. However in the meantime, Councillor Wolfe has no committee, and the Finance Committee has one less person for their January meeting now that Commissioner Paladino has left.

Staff Recommendation:

 BE IT RESOLVED THAT the Lethbridge Police Commission appoint Commissioner Wolfe to the Finance Committee effective immediately, until the Commission's January 26, 2026 organizational meeting.
